WHY IS SCRA COMPLIANCE IMPORTANT?

The Servicemembers Civil Relief Act (SCRA) helps military personnel focus their time and attention on duty by easing financial burdens during their military service. To comply with SCRA, financial institutions, telecommunication companies, and debt collection agencies need to identify SCRA-protected individuals in order to appropriately adjust interest rates and adequately handle other protections. Failure to comply with SCRA can cost financial institutions hundreds of millions of damages in fines and relief payments.



WHAT INDIVIDUALS FALL UNDER SCRA PROTECTION?

The SCRA covers active duty personnel, Reservists, and members of the National Guard while on active duty. The SCRA protection period begins at the beginning of an individual's military service and within 30 to 90 days after the date of discharge from active duty. Many individuals are eligible or at risk of becoming SCRA protected:

- ✓ Active duty personnel
- Non-active duty personnel placed on 'early alert'
- ✓ Veterans below age of 40
- ✓ All National Guard
- ✓ All Reservists
- ✓ ROTC Students
- Military dependents
